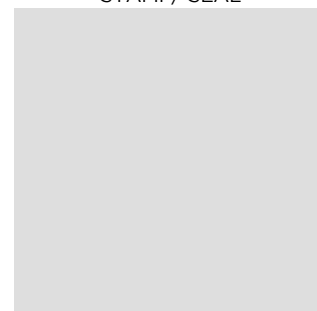

REGULATIONS GOVERNING THE GRANTING OF THE VM FONDATION JUNIOR PLAN "HEAD-START" SCHOLARSHIP AND PEP BURSARY

Each candidate must:

- 1. **Be an active VMBS saver (that is, their savings account should not be dormant).**
- 2. Sit the Primary Exit Profile (PEP) in the year of applying.
- 3. Have completed the **VM Foundation Junior Plan "Head-Start" Scholarship and PEP Bursary Application Form** and submitted it to a VMBS Branch on or before the closing date.

- 4. Not be a recipient of any other Scholarship/s for the given year.

Only candidates who have been awarded a place in a high school will be eligible for a scholarship or bursary. **The applicant with the highest PEP score in each county** in which the past school is located, as ranked by the Ministry of Education, Youth and Information, will receive a **scholarship valued at JMD \$50,000.00 per annum** for his/her 5-year study at a LOCAL high school.

The applicant with the highest PEP Score in the specific school as confirmed by the Ministry of Education, Youth and Information will receive a **one-time bursary valued at JMD \$50,000.00.**
